







# REGIONAL WORKSHOP ON "WINDOW 2" OF IPA III 2021-2027 "GOOD GOVERNANCE, EU ACQUIS ALIGNMENT, GOOD NEIGHBOURLY RELATIONS AND STRATEGIC COMMUNICATION"

Skopje, North Macedonia October 12-13, 2022



### **Background**

The new financial perspective IPA 2021-2027 (IPA III) is based on lessons learnt from previous perspectives IPA 2007-2013 and IPA 2014-2020, in order to ensure further, smooth implementation of defined goals and priorities, which are in line with the EU enlargement strategy and along the line of commitment of the Western Balkan countries regarding future membership in the European Union. The allocation for the Instrument for Pre-Accession, supporting beneficiaries on their path to fulfilling the accession criteria in MFF 2021-2027, will be 14.162 billion €. For the period 2021-2027, the new instrument should allow for sufficient flexibility to take into account evolving circumstances. No fixed or indicative national/geographical envelopes will be established, although a principle of "fair share" allocation for beneficiary countries will be integrated, as well as a "performance-based principle".

The IPA III Regulation has been adopted in September 2021, with a retroactive application from 1 January 2021. Beneficiaries submitted the revised "Strategic Response" documents, which describe how each beneficiary plans to utilize IPA III Financial Assistance and in particular, to provide an articulation of actions planned across the key thematic priorities within each of the five thematic windows. The quality of the Strategic Response is of utmost importance, having in mind that this is the key document for planning and programming of IPA III which should clearly show how countries are planning to utilize the resources for achieving the reforms and development goals.

The drafting process of the Action Fiches and the Action Documents for IPA 2021 and 2022 proved challenging for the following reasons, which were further worsened by the COVID-19 pandemic and restrictions on meetings: (i) the lack of National Sector Strategies covering the period post-2020 (in many cases extended to 2022 through Action Plans); (ii) difficulties in coordination by lead institutions, due to the large number of stakeholders involved; (iii) delays in the finalization of the IPA III legal framework and particularly the absence of methodological guidance and the programming framework; iv) the request to anticipate the preparation of Action Fiches before drafting the Strategic Response; v) insufficient availability of technical assistance in some Beneficiaries to support preparation of Action Documents and supporting documents and (v) criteria and timing for the maturity assessment were not realistic.

In order to tackle, discuss, debate and brainstorm on the challenges as well as to envisage the future steps on all the aspects related to IPA III, ReSPA and GiZ, in coordination with DG NEAR services are organizing **a set of activities throughout the Western Balkans** which are bringing together representatives of NIPAC Offices, departments in change of Strategic Planning, IPA Unit of relevant Line Ministries, renowned experts from the region and beyond as well as representatives of the European Commission and EU Delegations. The set of activities consist of a Regional Conference as well as 4 separate regional workshops, each of them dedicated to a specific thematic Window of IPA III framework, aiming to foster clarity and well-established processes in advance as a lesson learnt.

The present workshop will be focused on **Window 2 "Good Governance, EU acquis alignment, good neighbourly relations and strategic communication"**, which consists of the following indicative thematic priorities: Good Governance, Administrative capacity and EU acquis alignment, Good neighbourly relations and reconciliation, and Strategic communication, monitoring, evaluation and communication activities.
