Programme and Agenda

Background

In order to enable governments to plan and execute well-defined policies it is essential to ensure that a well-structured and comprehensively established policy development cycle is in place. According to the logic of the policy development cycle, governments need to have a good, evidence-based understanding of the policy issues they want to address, as well as tools to constantly monitor the implementation of the designed and approved policies that allows taking the right and timely management decisions ensuring that the envisaged policy objectives can be achieved.

The logic of the policy development cycle:



Monitoring and reporting are essential parts of the policy-making cycle. They provide both policy makers and decision makers with information on the progress made (or lack of it) in achieving policy objectives and implementing planned activities. The information presented in regular monitoring reports allows the identification of issues impeding the reform process, as well as the identification of any corrective measures that may be needed. Thus, monitoring and reporting is not a box-ticking exercise, but rather a hands-on management tool. Analysis of monitoring reports carried out by SIGMA in a number of countries has shown that they often lack the quality needed to perform the role of a management tool.

This seminar is focusing on the monitoring and reporting aspects of the policy development cycle. During the course of the seminar participants will be introduced to the general concepts of monitoring and reporting, some specific aspects and technicalities of good monitoring and report development, as well as good international practices on these aspects. Achieving this the seminar will focus on:

- 1. the conceptual positioning of policy monitoring and reporting in the policy management cycle
- 2. the prerequisites for effective monitoring (why sound planning is a pretext for good monitoring)
- 3. the key elements of a sound monitoring and reporting system
- 4. roles, responsibilities, processes and success factors for monitoring and reporting
- 5. advice on how to formulate good reports to various audiences and how to use reporting smartly for accountability and management purposes

The seminar will provide a forum to introduce and understand in details the SIGMA <u>Toolkit for the</u> <u>preparation, implementation, monitoring, reporting and evaluation of public administration reform</u> <u>and sector strategies</u> and especially to present the new <u>Annexes</u> of this document devoted to enhancing the quality of policy monitoring reports.

Since, over the past few years substantial progress has been made in the Western Balkan economies on developing and monitoring public policies, especially in the framework of their public administration reform frameworks, the seminar is also offering a platform to facilitate discussion amongst civil servants on recent developments, as well as on key challenges and how to overcome them. Consequently, this event is a mixture of knowledge transfer and capacity building through conceptualization, practical examples and exercises and facilitated networking of professionals to learn from each other and think jointly about the way forward.

Owing to the current Covid-19 pandemic, the seminar is organised online (i.e. as a Webinar), for two consecutive days, respecting the different circumstances of learning and exchange of views with the use of the online environment. Consequently, the length of the days and the details to be covered are adjusted to the limitations of the Webinar environment.

The first day of the Webinar, hence, is devoted to "set the stage" and share knowledge about the key elements of successful monitoring, while the second days is offered for exchange of views on the current practices in the Western Balkans and reflect to them in light of international good experience.
