Answer: Those categories will be created and maintained in the LMS and should be available in the API.

Under the Availability and Registration section of the Annex III it is stated "If a group is not full, a "register" button should allow the user to first register in the LMS system and then enrol in the selected training...". Is it sufficient for this part only that the register button leads to the detailed training page on the LMS and the registration and login will be done by the LMS? After the candidate has registered, the LMS should notify us of the availability of the training and we can refresh this periodically if necessary....

Answer: Yes, it is sufficient. The register button can lead to the registration form <a href="https://lms.napa.gov.rs/login/signup.php">https://lms.napa.gov.rs/login/signup.php</a>. A detailed training page in LMS is available only for registered users.
